The exemption is included in the Energy Tax.





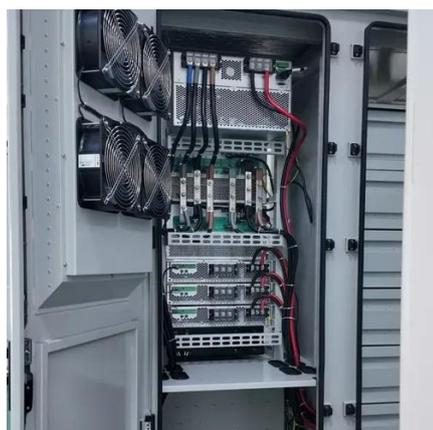
