Overview

According to RBI guidelines, you can store jewelry, property-related documents, loan papers, birth or marriage certificates, insurance policies, and legally valid items in your locker for long-term safety. However, storing cash or currency in lockers is strictly prohibited. In this phase, the account holders who have submitted their agreements on or before 31st December 2023 must sign a revised agreement and submit it to their respective bank before 31st December 2023. Moreover, A bank locker is a secure metal box located within a bank's strong room or vault. 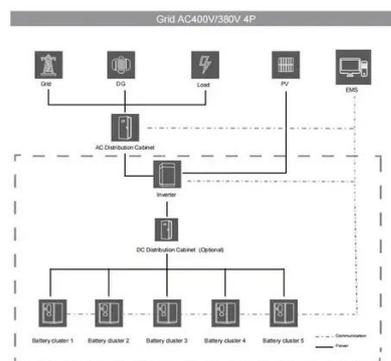
