China will cut export subsidies for solar panels and batteries in the coming months, a move mainly aimed at curbing domestic overcompetition and consolidating two sectors where China is dominant, said analysts who also expect it will help ease trade tensions with Europe. Authorities will cancel. (Yicai) Jan. 12 -- China plans this year to remove export tax rebates for solar products and phase out those for batteries. Value-added tax rebates on 249 exported products, including photovoltaic cells, will be withdrawn starting from April 1, the Ministry of Finance and the State Taxation.


