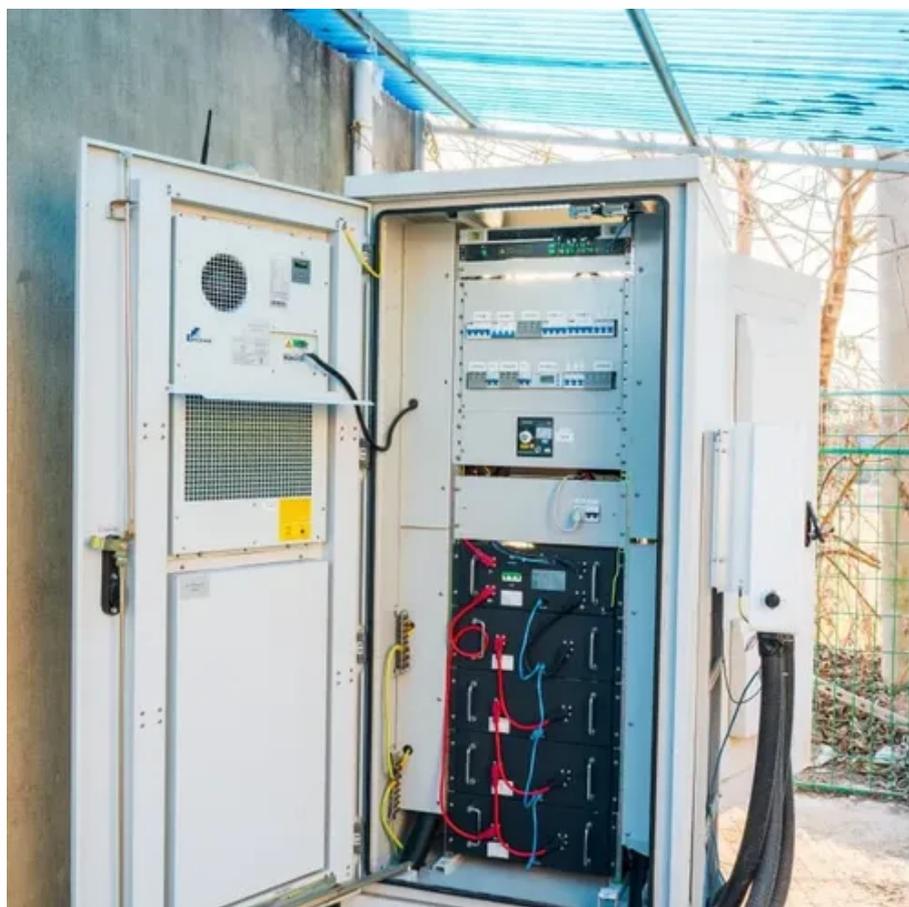




Cyprus Mobile Energy Storage Container Three-Phase Discount






Overview

The scheme, funded by the European Union (EU) Just Transition Fund (JTF), aims to curb the waste of curtailed renewable energy generation, increase the grid's hosting capacity for renewables, and reduce energy costs through energy storage technologies. Cyprus' Ministry of Energy, Commerce and Industry has launched a subsidy scheme for energy storage systems that can be added alongside existing renewable energy plants. Eligible renewable power plants should be remunerated either by feed-in tariffs (FiTs) or net billing systems. The scheme, funded through the 'THALIA 2021-2027' Cohesion Policy Programme and the Just. The Scheme includes calls for proposals for EU grants targeting hybrid energy systems (combining renewable energy and storage installations) under the Just Transition Mechanism (JTM), Pillar I Just Transition Fund (JTF).
