Overview

The most direct regulation of solar companies occurs at the state level. Public Utility Commissions (PUCs), sometimes called Public Service Commissions (PSCs), are responsible for setting the rules that govern how residential solar systems connect to the electric grid. The FTC investigates complaints about misleading advertising, predatory contracts, high-pressure sales tactics, and misrepresentations about the costs and benefits of solar installations. The Solar Interconnection Standards & Policies - Systems that connect to the electric grid are often affected by state and local interconnection standards. and across the country to establish supportive policy frameworks that allow solar to compete in the marketplace and offer cost-competitive, reliable energy to consumers.

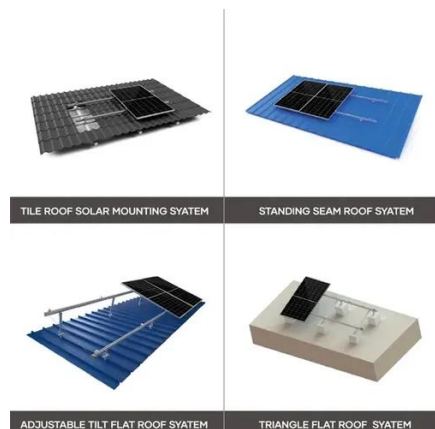

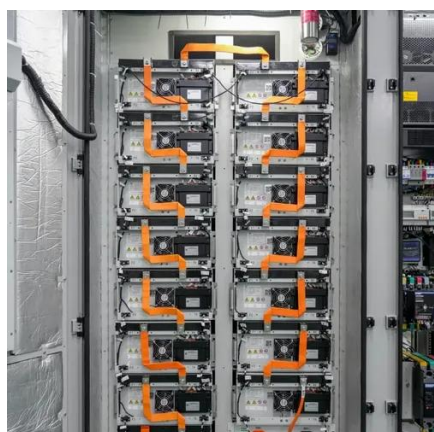
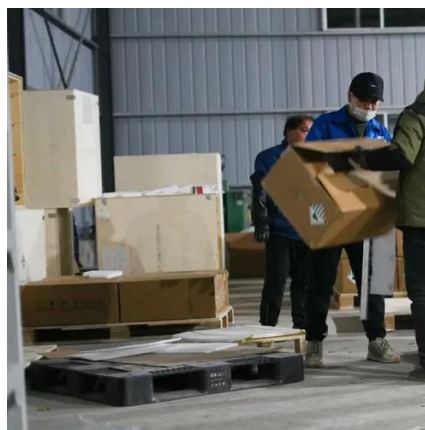
