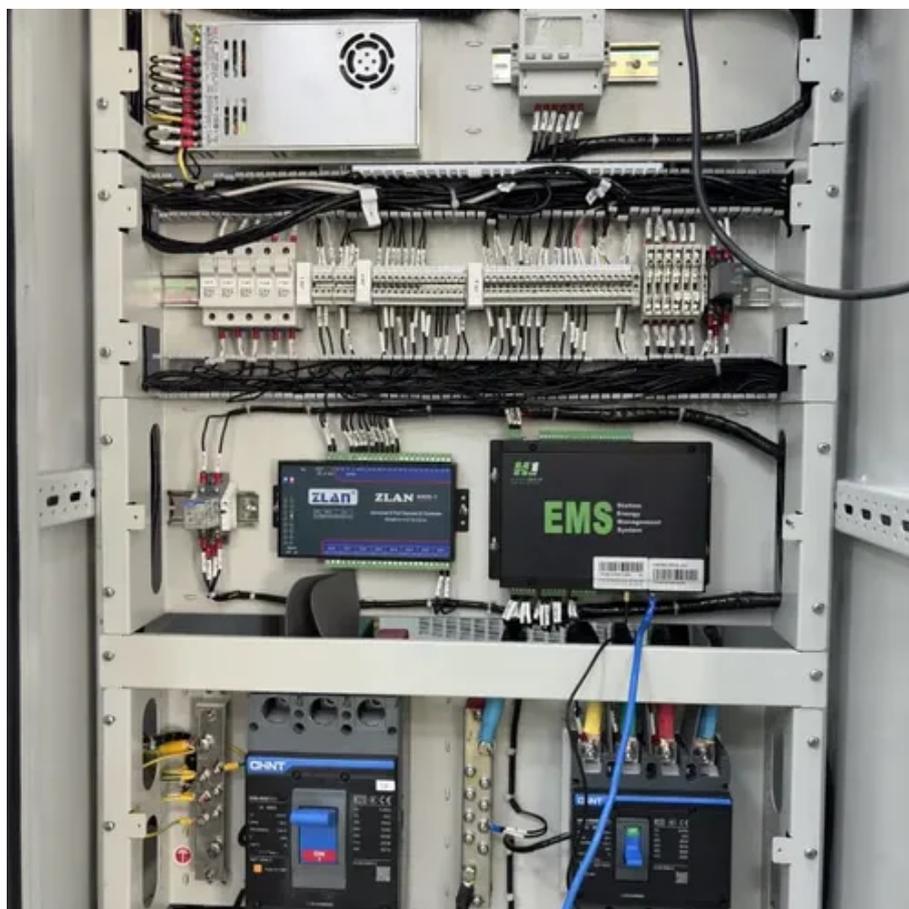




Electric vehicle incentives pristina





Overview

The subsidy amounts vary by vehicle type, ranging from €250 for electric mopeds and light tricycles to €500 for electric motorcycles, heavy tricycles, and quadricycles. Fully electric passenger cars and light commercial vehicles (M1 and N1 categories) are eligible for the maximum. Serbia will continue to offer purchase premiums for electric cars of up to 5,000 euros in 2025. The budget for this year is 170 million dinars, which corresponds to just under 1. Private individuals and entrepreneurs can submit applications until the end of October. 8/2025, published the new Decree on the Conditions and Manner of Implementation of Subsidised Purchase of New Electric Vehicles (“Official Gazette RS”, No. Citizens will be able to start submitting. Electric Mobility invests in green vehicles with EBRD loan and EU grant. In response, Kosovo is looking into ways to reduce vehicle emissions by investing in a new. Requests for subsidies to purchase brand-new electric vehicles must be submitted by October 31, with detailed instructions available on the Ministry of Environmental Protection's website.

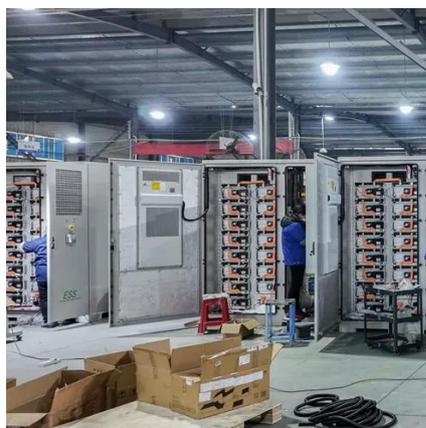
