Warranty commences from the 90th day after the date of the product shipment from Huawei, or the date on which Huawei receives a formal service request for the product, whichever is earlier. When the grid power is insufficient, the energy stored in the batteries is output to loads through the SmartPCS. A Replacement Product shall be the Customer's sole and entire remedy in respect of (360) days from the date of replacement, whichever is longer.

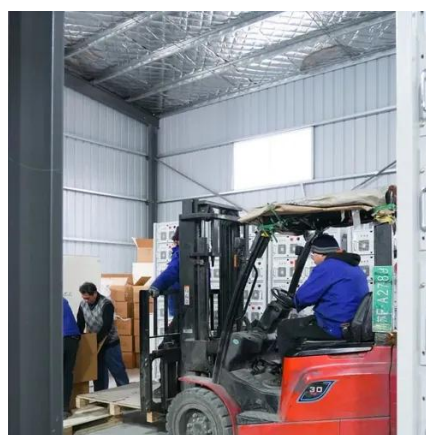
