Overview

This Letter of Intent (“LOI”) is designed for a solar power purchase agreement (“PPA”). What Is a Letter of Intent (LOI) for a Solar Project?

A letter of intent for a solar project is a preliminary document that outlines the key terms and mutual understanding between parties involved in a solar energy initiative. It serves as a foundation for negotiations, detailing project scope. An increasing number of retail, office, industrial and warehouse/distribution property owners are utilizing electricity generated by on-site photovoltaic (also referred to as “pv” or “solar”) systems to meet a portion of their properties' electrical energy needs. 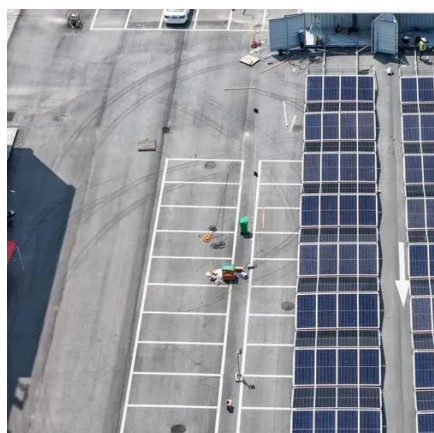
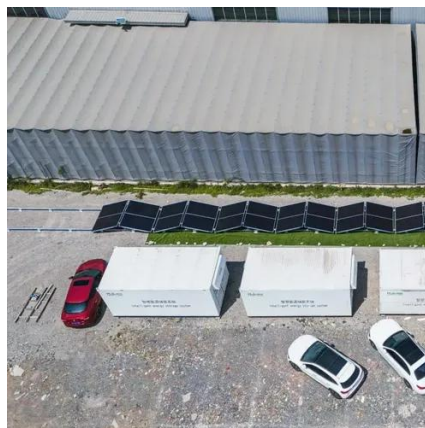
