




# Solar components for cuban enterprises

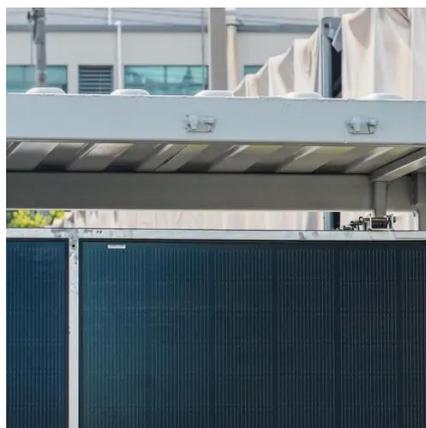
