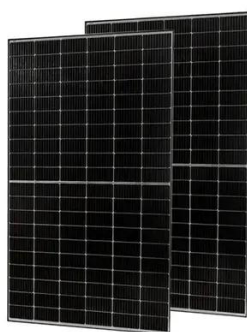

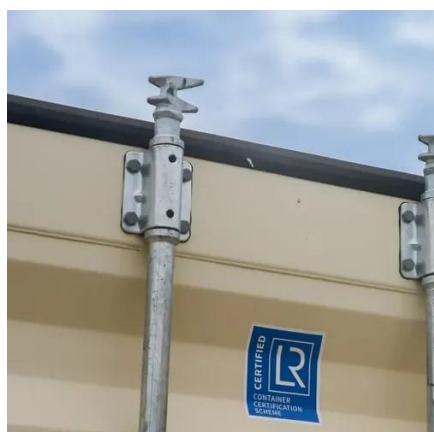
The Probation Department provides both investigation and supervision services to the 48th Judicial District Court. The Department deals exclusively with individuals age 17 and over.

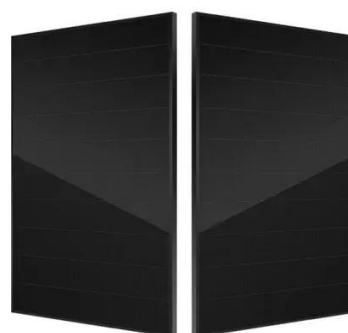

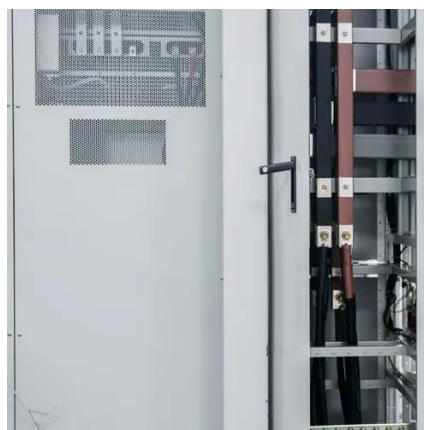
