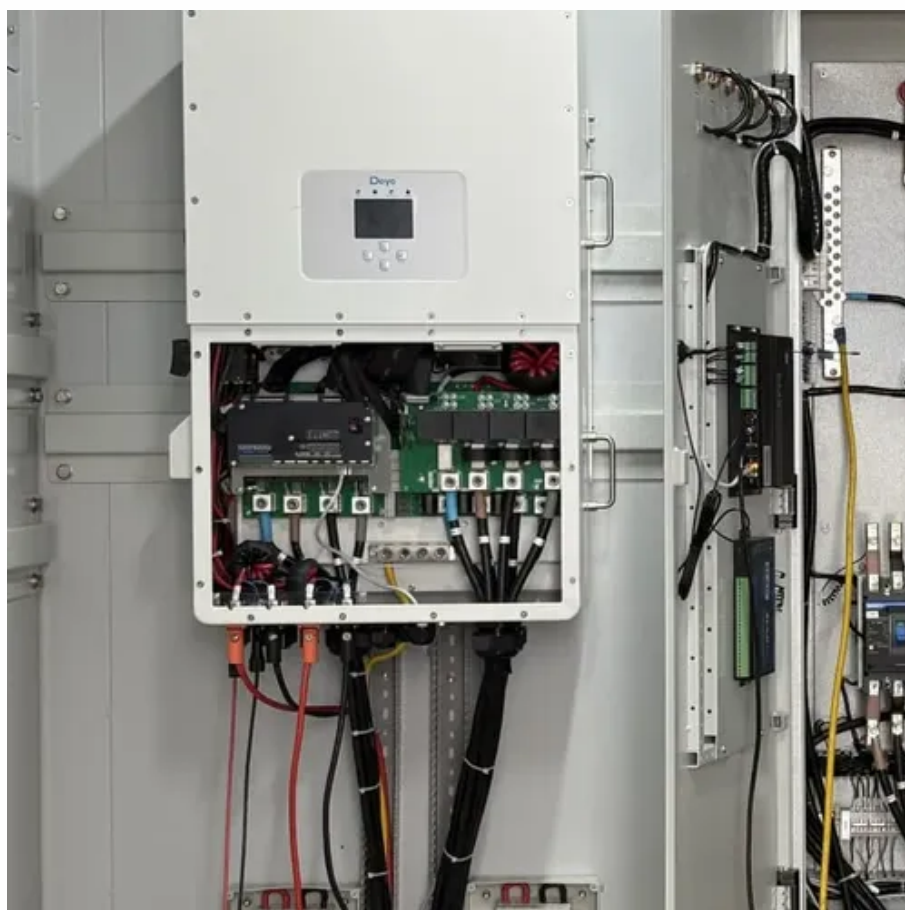




# The scam of installing photovoltaic panels in rural areas was exposed





## Overview

We'll walk you through the most common solar scams, the red flags that should make you pump the brakes, and how to find installers you can actually trust. Disclaimer: This article is intended to provide an informational overview of consumer protections for interested homeowners. The scams vary, but here's the gist: someone claiming to be with the government or your utility company promises big savings on your utility bills from solar energy or other home improvements designed to increase energy efficiency. If you agree to the scammer's offer, it could cost you tens of thousands. From deceptive sales pitches to illegitimate paperwork, we'll cover five key areas every homeowner should scrutinize:

- 1) The potential harm of fraudulent warranty documents. With that demand comes fierce competition within the solar panel market. The con starts with a fast-talking salesperson offering a "limited time offer" for a free solar energy install. People complain that they were deceived about costs and savings, misled about loans and the cons.
- 2) Check what resources are available in your state: [usa.gov/state-consumer-purchase-agreement](http://usa.gov/state-consumer-purchase-agreement), or subscribing to a community solar.
