Both the exhaust ventilation requirements and the explosion control requirements in NFPA 855, Standard for Stationary Energy Storage Systems, are designed to mitigate hazards associated with the release of flammable gases in battery rooms, ESS cabinets, and ESS walk-in units. However, exhaust fans are used for safe transport of new or damaged lithium-ion batteries. Explosion-proof measures for energy storage equipment include: the implementation of robust containment systems, rigorous safety protocols during maintenance, meticulous design standards for equipment, and regular training for personnel due to arc flash or gas explosion. These safety elements are certified and tested to open at the required pressure. This document reviews state-of-the-art deflagration mitigation. Designed specifically to contain volatile substances and minimize the risk of ignition, explosion-proof cabinets are more than just storage—they're a frontline defense.

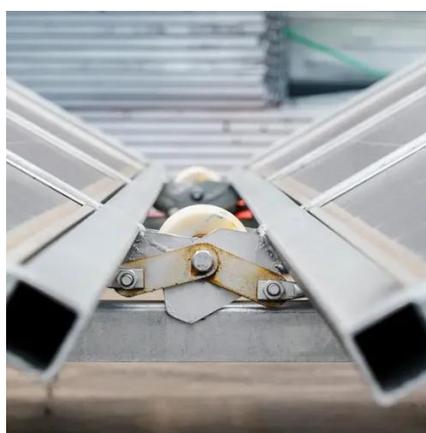
