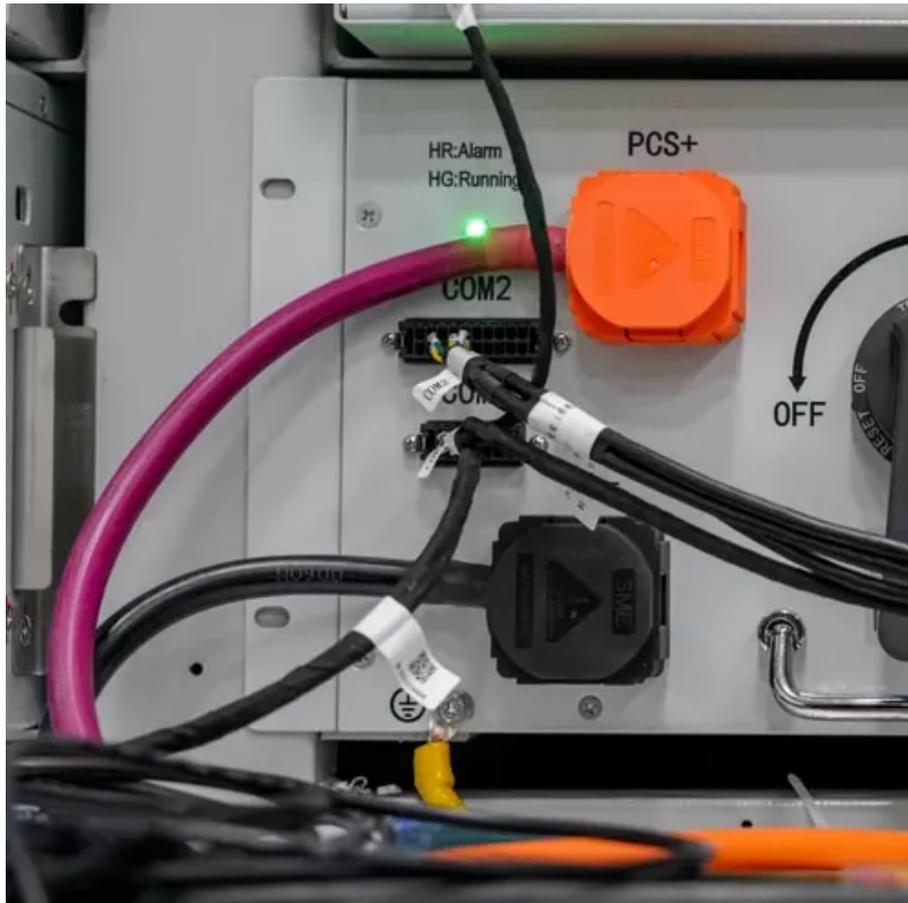

If you buy the panels with cash or finance them through a loan, the credit is yours. But if you go with a lease or a power purchase agreement, the installer keeps the credit.

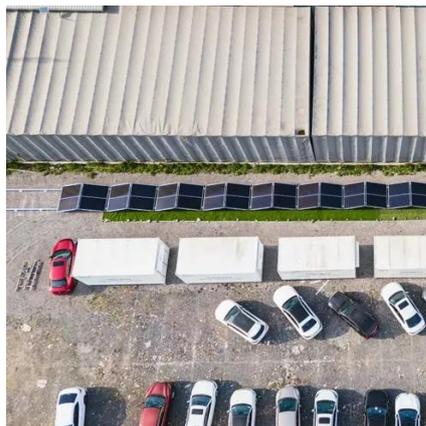

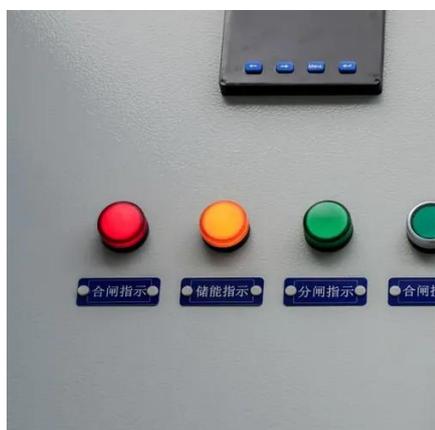
